### REGULAR BUSINESS MEETING BOARD OF EDUCATION

October 1, 2009 Board Room

EXECUTIVE SESSION: Roll call indicated that a majority of the Board – Dave Thomas, Second Vice President; Rick Rush, Treasurer/Secretary; and, Robin Johnson, Board member, met at 5 p.m. Upon motion by Rick Rush, seconded by Robin Johnson, the Board moved into executive session to seek advice of legal counsel regarding a student matter. Cynthia Stevenson, Superintendent, represented the administration. Sue Marinelli, President, joined the meeting at 5:10 p.m. Jane Barnes, First Vice President, was excused. The Board came into open session at 5:35 p.m.

#### 1. PRELIMINARY

- 01. **CALL TO ORDER:** A regular meeting was called to order by Sue Marinelli, president of the Board of Education, at 6:01 p.m. in the Board Room of the Education Services Center, 1829 Denver West Drive, Golden, Colorado, Thursday, September 17, 2009.
- 02. **WELCOME TO THE AUDIENCE:** Ms. Marinelli welcomed the audience.

Ms. Marinelli thanked the student choir from Foothill Elementary School, and director Emily Branum, for their performance before the Board of Education meeting.

- 03. **PLEDGE OF ALLEGIANCE:** At the invitation of Ms. Marinelli, the assembly repeated the Pledge of Allegiance.
- 04. **ROLL CALL:** Roll call indicated that a majority of the Board was present Sue Marinelli, President; Dave Thomas, Second Vice President; Rick Rush, Secretary/Treasurer; and Robin Johnson, Member. Cynthia Stevenson, Superintendent, represented the administration.

Jane Barnes, First Vice President, was excused from the meeting.

05. **APPROVE AGENDA:** Motion #1 (<u>Approve Agenda</u>): Upon motion by Mr. Rush, seconded by Mr. Thomas, it was unanimous to approve the agenda as presented.

3. APPEAL OF DECISION REGARDING EXPULSION OF A STUDENT (EL-10): MOTION #3 (Affirm Decision): Upon motion by Mr. Rush, seconded by Mr. Thomas, it was unanimous to affirm the Superintendent's decision of August 17, 2009, that a student at Ralston Valley High School, student identification number 619308, be expelled from all Jefferson County Public Schools; that the period of expulsion continue through October 1, 2009; that the Board adopt the Final Determination of Appeal as presented; and that the Administration be directed to serve the Final Determination of Appeal on the student and the student's parents via certified mail, return receipt requested.

Representatives from Lotus School for Excellence provided a power point presentation about their application and answered questions of the Board of Education.

Representatives from Rocky Mountain Deaf School High School presented a summary of their application and answered questions of the Board of Education.

- 02. **SELECTION OF COLORADO ASSOCIATION OF SCHOOL BOARDS DELEGATE (GP-1):** Motion #4 (<u>Appoint Delegate</u>): Upon motion by Mr. Rush, seconded by Mr. Thomas, it was unanimous to appoint Sue Marinelli as delegate to the Colorado Association of School Boards Fall Conference and Delegate Assembly.

8. **BOARD AND SUPERINTENDENT COMMENTS:** Ms. Marinelli visited schools with each of the four community superintendents, was intrigued by the Daily Five program at schools, and attended the Evergreen Middle School dedication.

Mr. Rush visited schools with Community Superintendent Holly Anderson. At articulation area meetings he observed how principals are in touch with their

changing community demographics. Attending accountability meetings, he heard positive comments on Response to Intervention and Read 180 program implementations. He attended the Jeffco Marching Festival.

Ms. Johnson thanked community superintendents for arranging school visits for her at all schools in her articulation area but one. She attended the Outdoor Education Lab School /Lockheed Martin solar tour opening.

Mr. Thomas attended the Second Wind event, the largest suicide prevention event in the nation.
