3.01 Superintendent Appointment

Motion #4 (<u>Motion to Hire Superintendent</u>): Upon motion by Mr. Newkirk, second by Ms. Williams, the Board of Education approved the motion to employ Daniel M. McMinimee as superintendent of Jeffco Public Schools effective July 1, 2014, contingent upon successful negotiation and Board approval of the superintendent contract and pursuant to the terms contained in such contract.

A friendly amendment by Ms. Fellman to bring forward three finalists was declined.

Motion #5 (<u>Motion Superintendent Contract</u>): Upon motion by Ms. Dahlkemper, second by Ms. Fellman, the Board of Education denied the motion to approve a year to year contract for the incoming superintendent.

A friendly amendment by Mr. Witt to approve a 3-year contract with a 1-year renewal was declined.

Motion #6 (Motion Lower Base Salary): Upon motion by Ms. Fellman second by Ms. Dahlkemper, the Board of Education denied the motion to lower the base salary of the superintendent to \$200,000.

A friendly amendment by Ms. Dahlkemper to cap the termination buyout to \$100,000 (50% or 6 months' salary) was accepted.

A friendly amendment by Mr. Witt to adjust the base salary to \$240,000 with a \$40,000 performance bonus was declined.

Final Resolution: Motion Fails Yea: Ms. Dahlkemper, Ms. Fellman Nay: Mr. Newkirk, Ms. Williams, Mr. Witt Motion #7 (<u>Motion Performance Goals</u>): Upon motion by Ms. Dahlkemper second by Ms. Fellman, the Board of Education denied the motion to have a conversation on the superintendent's performance goals at the meeting of June 5, 2014, and a vote to adopt the goals at the June 19, 2014 meeting.

A friendly amendment by Mr. Witt to implement goals as of September 1, 2014 was declined.

A friendly amendment by Ms. Fellman for the contract to go into effect when the goals are established was accepted.
