1.02 Call to Order: 9:00 a.m.

2. Study/Dialogue Session

2.01 Orientation: Governance Review

Caplan and Earnest attorneys Jim Branum and Kristin Edgar presented information on the basics of policy governance and the role of the board member. The overview and discussion covered governance process policies guiding board member behaviors, Ends policies guiding the district and superintendent's work to reach an end (not specifically the means), revision of the Ends to accurately reflect current Board priorities on student achievement data,

Jeffco's 2020 vision, public relations/leadership, community input on Ends, executive limitations and evaluation of superintendent, teacher dismissals, and conflict of interest and financial disclosure reporting.

2.02 Orientation: Finance and Budget Overview

Kathleen Askelson, chief financial officer, provided an overview of finance and the Jeffco Schools budget including fund accounting, revenues by fund, reserves, charter school funding, school based budgeting, state budget update and the forecast for the 2016/2017 Jeffco budget. Discussion covered bond and mill obligations, fees, enterprise funds, impact of TABOR, and district reserves.
