2.02 Direction on Facilities Master Plan (EL-8)

Motion #2 (Motion on 6-8 Model): Upon motion by Mr. Rupert, second by Ms. Lasell, the Board of Education approved that Jefferson County Public Schools move toward a K-5/6-8 elementary and middle school configuration generally, with exceptions for where we already have K-8 or K-6/7-12 configurations, and Foster Elementary where we have a special bilingual program that benefits the 6^{th} grade remaining in that school.

2.03 Direction on Bond Package

After discussion of the Bond Package, the Board of Education acknowledged their intent to authorize a bond issue for the November 2016 election ballot in an amount not to exceed \$535 million, to be discussed further in August or September.

2.04 Direction on Mill Levy Override (EL-11)

After discussion of the Mill Levy Override, the Board of Education acknowledged their intent to authorize a mill levy override question for the November 2016 election ballot in an amount not to exceed \$33 million, to be discussed further in August or September.

There being no further business to come before the Board, the meeting was adjourned at 10:23 p.m. The next regular meeting of the Board of Education is scheduled for September 8, 2016.
