## 1. Preliminary

#### 1.02 Call to Order

A special meeting was called to order at 5:02 p.m. by Dave Thomas, President of the Board of Education, in Conference Room 3AB of the Education Center, 1829 Denver West Drive, Golden, Colorado, Thursday, November 18, 2010.

#### 1.03 Roll Call

Roll call indicated that a majority of the Board was present - Dave Thomas, President; Laura Boggs, Second Vice President; and, Paula Noonan, Treasurer. Dr. Cynthia Stevenson, Superintendent, represented the administration. # 2. Study/Dialogue Session

# 2.01 Monitoring: 1st Quarter Financial Report (EL-5, 6)

**PURPOSE:** The Board of Education will monitor the districtwide financial condition as outlined in executive limitation policies 5 and 6, Financial Planning and Budgeting, and Financial Administration, respectively.

**DISCUSSION:** The external auditor from Clifton Gunderson reviewed agreed upon procedures and noted no unusual trends not already reported were found. District staff reviewed the report and identified funds, departments and schools to monitor closely throughout the year. Two members of the Financial Oversight Committee commented on what the committee planned to review over the coming year and research for long-term solutions to the Board.

**CONCLUSION:** The Board reviewed the first quarter financial report and thanked the Financial Oversight Committee members for their efforts.

Board discussion covered the Board's leadership role in the plan, reflection of members' desire for innovation and timelines for accomplishment of targets, verbiage being student versus stafforiented and the ability to measure same.
