Columbine Pass - \$14.00



For Disabled Colorado Residents

The Columbine Pass offers a discounted pass for disabled Colorado residents that is transferable between vehicles. The Columbine pass is available by application only with proof of eligibility.

The Columbine Pass will allow permanently and totally disabled individuals to:

- Purchase an entrance pass for \$14.00 annually instead of the regular vehicle cost of \$70.
- Transfer the pass between vehicles, allowing the Columbine Pass holder and other vehicle occupants park entrance. The pass holder must be present for the pass to be valid.
- Visit Colorado's 41 State Parks for a 12 month period from the date of purchase. (Please note: An additional \$3 annual fee will be collected at Cherry Creek State Park for the Water Basin Authority.)

Who is eligible for a Columbine Pass?

To qualify for a Columbine Pass, the applicant must be a Colorado resident and provide acceptable documentation of a total and permanent disability from one of the following:

- A photocopy of a TPQY or Benefit Verification form from the Social Security Administration (obtained by calling 1-800-772-1213 and asking the operator for your TPQY); or
- A photocopy of a letter from the Veterans Administration indicating a permanent and total disability (call the VA at 1-800-827-1000 for information); or
- A photocopy of a Division of Workers' Compensation "Final Admission of Liability" form indicating permanent total disability; or
- A signed physician's letter attesting that there is a physical or mental impairment which prevents gainful employment and that the impairment is reasonably certain to continue throughout the person's lifetime.

To avoid time delays in processing your application, the above documentation should be current and issued within the past 12 months.

How can I get a Columbine Pass?

Applications are also available at the region offices of Colorado Parks and Wildlife and the Division headquarters in Denver – not at the individual parks or through any pass concessionaires. Columbine Pass applications can be obtained and will be accepted by mail or in person at these locations:

With the completed Columbine Pass application, you must include:

- A copy of your current Colorado Driver's License or Colorado I.D.
- Recent documentation of "total and permanent disability" from the Social Security Administration, the Veterans Administration, the Colorado Division of Workers' Compensation or a Physician's Letter.
- A check or money order in the amount of \$14.00 payable to: Colorado Parks and Wildlife.

When the proper application materials are received, the Columbine Pass will then be mailed to the approved applicant within 30 days. Candidates whose application has been denied will receive written notification within 20 working days of application receipt by the Division. Any fees paid will be refunded.



Colorado Parks and Wildlife Columbine Annual Pass Application

The Columbine Annual Pass is offered at a discounted rate to qualified Colorado residents. To qualify, you must provide one of the following documents which verifies you have a *total and permanent disability*.

- o The Social Security Administration "TPQY" or **BENEFICATION VERIFICATION** form showing a permanent and total disability (obtained by calling the SSA at 1-800-772-1213)
- o Letter from the Veterans Administration indicating a permanent and total disability (call the VA at 1-800-827-1000 for information)
- o A licensed physician's signed statement attesting to a *physical or mental impairment which prevents gainful employment and is reasonably certain to continue throughout the applicant's lifetime*.
- o Colorado State Division of Worker's Compensation "Final Admission of Liability" form indicating permanent and total disability.

Please provide a copy of your Colorado Driver's License or Colorado I.D. when mailing in your application.

The Columbine Annual Pass is valid for a 12 month period from the date of purchase. The pass holder must be present for the pass to be valid. With this \$14.00 pass, the pass holder and other vehicle occupants will be allowed unlimited entrance to Colorado State Parks for the duration of the pass in any vehicle they choose. An additional \$3.00 annual fee for the Cherry Creek Water Basin Authority is charged when visiting Cherry Creek State Park.
